Membership Information: You must have purchased your card by the phone entry date of a rodeo you enter in order to receive points for that rodeo. The MRA uses the postmark on mailed applications as the card purchase date. All renewals and applications for membership must have a new application each year. LATE FEES: Applications postmarked after April 15<sup>th</sup> will need to include a late fee of \$10. (Late fees do not apply to first time card buyers or associate members) Applications that owe late fees or fines will be sent back. MRA cards are available through the MRA Secretary, at monthly meetings, or by mailing your application, dues and a self addressed stamped envelope to the MRA office. Carry your MRA card at all times to present to the rodeo secretary or expect to pay the \$15 permit fee. If you lose your card, you may have it replaced by the MRA office for a fee of \$25. Rodeos that are not first sanctioned MRA: The first sanctioning rules apply. All Entries fee are CASH ONLY. (Rev 11/07 HG)
